

You see exactly how shallow this is by looking at it that way. It is pointless, it is discriminatory, and it solves nothing. Unfortunately, religion and incompatible ethnicity, not land, is largely at the root of this, not violence or supposed land grabbing – these are only the symptoms.

The proposal is like trying to fix two broken backs with an asprin administered to one party, and then running around

telling everyone how wonderful you are because you applied inappropriate medication that will sort your imagined naughty one out.

The RIBA really have no business with a matter so complex that it has roots 4,000 years ago and still is not sorted out.

But it gets better:

I see the Israeli architects
have gone straight to the top
with this. I do not blame them.
I suspect the RIBA will get
a kicking as a result – either
overtly or behind the scenes.
Even worse, they may just get
dismissed as a non-material and
irrelevant interference.

We all can watch the profession slide further downhill now, whichever way this goes, because any form of kicking or dismissal will do no practicing architect a favour. It is an own goal, and a sneaky one at that.

RIBA have no business meddling with things they know nothing about and where they certainly have no skills to enable a professional, considered and effectual opinion.

Should this become a general public scandal, members should call at the very least for apologies
